<b>Preschool and older (3 yrs &amp; up and toilet trained) full days</b>
4 days per week M,T,W,Th 8:30 am - 3:00 pm: \$1060 per month
5 days per week 8:30 am - 3:00 pm: \$1190 per month
<b>Toddler (18 Months - 3 years old) half days</b>
4 days per week M,T,W,Th 8:30 am - 12:30 pm: \$770 per month
5 days per week 8:30 am - 12:30 pm: \$940 per month
<b>Toddler (18 Months - 3 years old) full days</b>
4 days per week M,T,W,Th 8:30 am - 3:00 pm: \$1190 per month
5 days per week 8:30 am - 3:00 pm: \$1410 per month

## Contract Tuition Agreement for August 28, 2023 - August 23, 2024

- I understand that Before School Care (7:00 am- 8:30 am), After School Care (3:00 pm - 5:00 pm), and “No School” days will be billed at \$8.00 per hour, per child under the age of 3, or if not fully toilet trained, and \$7.00 per hour for children that are over the age of 3 and are fully toilet trained. These charges are then added to the next statement at the end of each month.
- If used, I agree to pay the Drop In rate of \$9.00 per hour for hours outside of the regular contract schedule that are used during regular school days.
- I agree to pick my child up at the contracted time and I am aware that the charge after 5:00 pm is \$1.00 per minute.
- I agree to pay an annual non-refundable registration fee of \$150.00, which is due before my child’s first day of school.
- I agree to pay a deposit that is equivalent to one week’s tuition, which is due before my child’s first day of school. *Deposits may be refunded if all of the following conditions are fulfilled:*
  - I submit a 30 day written notice to terminate the contract
  - All my payments are current
  - I have a zero balance by the 5th of each month
- I understand that tuition is due on or before the first day of each month, and that a late fee of \$5 per day will be assessed for payments received after the 5th day of the month.
- I understand that I will be paying a monthly tuition fee (see chart above) on the first of each month, as well as any childcare charges of \$7.00 or \$8.00 per hour for the previous month.
- I understand this is a **12 month** contract, and is effective August 28, 2023 - August 23, 2024.
  - Breaking my contract will result in my child being placed on the waitlist upon re-enrollment
  - Schedule changes (defined as subtracting days, changing from full to half day attendance, etc.) require a 30 day written notice.
- I understand that all enrollment paperwork, health appraisals, immunizations, registration fees, and deposits must be turned in before the first day of school. If any of these items are incomplete or not submitted on time, my child(ren) will not be allowed to attend school until all items have been turned in.
